### Minutes

#### **REVIEW OF GRANT REQUESTS TOTALING \$214,840.00 for the following grants:**

1. **Veterans Memorial Park of Kentucky, Inc. (KY0076342)**
  - Request for funding in the amount of **\$35,840** to educate visitors about the Mexican War and the Texas War for Independence.
  - The Board voted to approve an obligation of **\$35,840**

    - # Motion for approval unanimously carried.
2. **Fire Mission Ministries (KY0081525)**
  - Request for funding in the amount of **\$19,000** to provide veterans with a safe place to heal from addiction, offering them help to reintegrate into society.
  - The Board voted to approve an obligation of **\$19,000**
    - # Initial Motion made by Richard Dallaire (American Legion)
    - # Motion seconded by Juan Renaud (KDVA)
    - # Motion for approval unanimously carried.
3. **Kentucky Historical Society (KY0066309)**
  - Request for funding in the amount of **\$25,000** to showcase and provide the history of Kentucky's women military veterans.
  - The Board voted to approve an obligation of **\$25,000**
    - # Initial Motion made by Juan Renaud (KDVA)
    - # Motion seconded by David Rummel (JECVO)
    - # Motion for approval unanimously carried.
4. **Kentucky Aviation Historical Society (Bowman Field Foundation) (KY0067819)**
  - Request for funding in the amount of **\$35,000** to provide a two-day festival highlighting the history of the field of aviation and providing a venue for all service members free of charge.

- The Board voted to approve an obligation of **\$35,000**

  - # Motion for tabling unanimously carried.

**5. Camp Hero Inc. (KS0019753)**

- Request for funding in the amount of **\$50,000** to provide mental health support services for veterans and first responders, using the outdoors and nature.
- The Board voted to approve an obligation of **\$50,000**
  - # Initial Motion made by Carl Kaelin (VFW).
  - # Motion seconded by Richard Dallaire (American Legion).
  - # After discussion this item was tabled pending a request for additional information reference services provided.

**6. Visual Presentations Inc. (KY0061902)**

- Request for funding in the amount of **\$10,000** to hold a KY Veterans' Parade to honor and celebrate our veteran community.
- The Board voted to approve an obligation of **\$10,000**
  - # Initial Motion made by Carl Kaelin (VFW)
  - # Motion seconded by Juan Renaud (KDVA)
  - # Motion for approval unanimously carried.

**7. Veterans Care Foundation (KS0028740)**

- Request for funding in the amount of **\$30,000** to lead a new holistic health initiative (Operations Restore) aimed at providing various services to KY veterans.
- The Board voted to deny an obligation of **\$30,000**.
  - # Initial Motion made by Juan Renaud (KDVA)
  - # Motion seconded by Carl Kaelin (VFW)
  - # Motion for approval unanimously carried.

**GRANT SUMMARY**

- Total amount of Grants approved: 5 of 7. 1 request tabled. **\$124,840**
- Marine Corps League & Hart County Veterans Committee grant requests were approved totaling **\$22,076**.
- Total amount approved: **\$146,916**

- Current members remain in place until Boards of Commissions approves new members.


