Latest VA News

VA accepting grant applications for a new program helping Veterans, their spouses transition from military service

Approximately \$4M in awards will support the successful transition of Veterans and spouses.

Eligible organizations providing employment-based resources and tools to help recently separated members of the Armed Forces and their spouses may <u>now apply</u> for grants from the U.S. Department of Veterans Affairs.

Through this new program, VA is set to award approximately \$4 million in grants through its Veteran and Spouse Transitional Assistance Grant Program in 2024. Each grant will be in increments of up to \$500,000 and is to be matched by the grantee organization.

Priority preference will be given to applicants that either provide multiple services or are in a state with any one of these criteria:

- A high rate of unemployment among Veterans.
- A high rate of usage of unemployment benefits for recently separated members of the Armed Forces.
- A labor force or economy that has been significantly impacted by a covered public health emergency.

Key services offered by grantee organizations may include resume assistance, interview training, job recruitment training, employment placement services, employment education and training, and referrals to employment. More information on grant eligibility can be found on the <u>webpage</u>.

"Organizations that provide transition services are critical to supporting our more than 200,000 men and women who leave U.S. military service every year. VA — in partnership with these organizations — aims to empower and provide Veterans and their spouses the necessary support to achieve their employment goals and build successful civilian lives following this critical transition period" said **Under Secretary for Benefits Joshua Jacobs**. "The Veteran and Spouse Transitional Assistance Grant Program underscores

VA's commitment to honoring Veterans and their family's service and sacrifice, and we encourage eligible organizations to apply."

Supporting Veterans and their families is a core pillar of President Biden's Unity Agenda for the nation. Since day one, the Biden-Harris Administration has focused on supporting an effective transition from military service to civilian life for Veterans and their spouses, including through expanded job training assistance. The Biden-Harris Administration and First Lady Jill Biden, through her <u>Joining Forces</u> initiative, continue to work to eliminate barriers to employment and increase economic opportunity for Veteran and military families.

This new grant program — the first-ever to be extended to military spouses — builds on the historic <u>Executive Order signed by President Biden</u> in 2023, which announced a series of new actions aimed at enhancing career stability, expanding employment resources, and improving transition assistance support for military-connected spouses.

VA offers additional services to help Veterans, transitioning service members, and spouses find and keep jobs through programs such as <u>Personalized Career Planning and Guidance</u> and <u>Veteran Readiness and Employment</u>. These programs provide career counseling, assessment, and education planning tailored to Veteran needs.

VA awards \$26.8M in grants to support legal services for Veterans experiencing or at risk for homelessness

The U.S. Department of Veterans Affairs is awarding \$26.8 million in legal services grants to a total of 108 public and non-profit organizations, all with the goal of increasing access to legal services for <u>eligible</u> Veterans experiencing or at risk for homelessness.

Ending Veteran homelessness is a <u>top priority for VA</u> and for the Biden-Harris Administration. These grant funds, made available as part of VA's <u>Legal Services for Homeless Veterans and Veterans At-Risk for Homelessness Grant Program</u>, more than double the total dollars and mark a 37% increase in grantees over <u>last year's inaugural grant cycle</u>.

"Every Veteran deserves access to safe, affordable and permanent housing, and we know that legal support is among the most needed services by Veterans experiencing or at risk for homelessness," said **VA Secretary Denis McDonough.** "Through these grants, we are working hard to ensure Veterans' unique civil legal needs are met and drive towards our ultimate goal of ending homelessness for all Veterans and their families."

This grant program is enabled by the <u>Johnny Isakson and David P. Roe, M.D., Veterans Health Care and Benefits Improvement Act of 2020</u> and ensures at least 10% of funding supports the provision of legal services for women Veterans. Individual grant awards are up to \$300,000 for a 14-month grant cycle starting Aug. 1, 2024. Grant recipients will deliver a variety of legal services to Veterans:

- Providing representation in landlord-tenant disputes to prevent eviction.
- Assisting with court proceedings for child support, custody, or estate planning.
- Helping Veterans obtain benefits like disability compensation.
- Defending Veterans in criminal cases that can prolong or increase their risk of homelessness, such as outstanding warrants, fines, and driver's license revocation.
- Upgrading characterization of discharges or dismissals of former members of the Armed Forces.

Legal services are one way VA is working to eliminate Veteran homelessness and meet the goal of placing at least 41,000 Veterans experiencing homelessness into permanent housing this year. Thanks in part to VA's efforts, the number of Veterans experiencing homelessness has fallen by nearly 5% since early 2020 and by more than 52% since 2010. The department has also expanded access to health care for homeless Veterans and called for a moratorium on foreclosures for Veterans with VA-guaranteed loans.

Meeting the needs of Veterans at risk or experiencing homelessness is a whole-of government effort. Today's grant awards complement other programs delivering needed services to at-risk Veterans, including the <u>recent \$57 million announcement</u> from the U.S. Department of Labor's Homeless Veterans' Reintegration Program to help Veterans experiencing homelessness re-enter the workforce.
