Veterans Affairs Life Insurance (VALife)



[Veterans Affairs Life Insurance \(VALife\)](#) is launching on Jan. 1, 2023, as a new guaranteed acceptance whole life insurance program for service-connected Veterans. Those currently enrolled in Service-Disabled Veterans Life Insurance (SDVI) may keep their coverage or switch to VALife.

Supplement Your Pension with Aid and Attendance

Did you know that VA's Aid and Attention and Household benefits can increase your pension payments to support the additional care you need? If you need help with daily activities, or if you are housebound, you may qualify for an increased VA pension to help pay for in-home care, assisted living, or a nursing home.

Raising Your VA Compensation Rates

As the cost of living goes up, VA ensures that your benefit rates do too! Starting Jan. 1, 2023, all compensation benefit rates have increased by **8.7%** to match adjustments made to Social Security benefits. This increase impacts [disability benefits](#), clothing allowance, dependency and indemnity compensation (DIC), as well as other VA assistance programs. Latest in PACT Act News--Important Information on PACT Act

SECVA McDonough remarks at PACT Act Week of Action *By: VA Secretary Denis McDonough*

On Friday, Dec. 16, 2022, VA Secretary Denis McDonough spoke at the [PACT Act Week of Action](#) at the Maj. Joseph R. "Beau" Biden III National Guard/Reserve Center. The following are his remarks from the event.

General Berry, thanks for the warm welcome, and for your three decades of service and leadership. The Delaware Guard's been defending our freedom since long before our founding — whenever and wherever the country needs them.

We all saw that kind of devotion in the actions of Tech Sergeant Matt Keefer — recognized last Friday with the Distinguished Flying Cross for his heroism in Afghanistan, responding to the tragedy at the Karzai International Airport a year ago August. And you're sending the 160th Engineer Company down-range come January. May God bless 'em and keep them safe.

It's an honor to be here at one of the last of the 100-plus events VA's hosting during this PACT Act Week of Action. To our Vets, their family members, caregivers, and survivors — we're forever in your debt, and we're fighting like hell to serve you as well as you have served us. We won't settle for anything less.

And thanks to the PACT Act that President Biden signed into law on August 10th, VA has expanded health care and benefits for millions of Vets and their survivors — including many of you here, today. If you or a loved one served in the Vietnam era, the Gulf War era or the Post-9/11 era, you may be eligible for new or increased care and benefits because of the PACT Act.

And here's what you need to know.

First, [apply for your benefits and care right now](#). If you're enrolled in VA care, get a quick and easy toxic exposure screening. If you're not enrolled, get enrolled. If you haven't yet applied for your PACT Act benefits, apply. You can do all that here, today, or you can call the Delaware Office of Veterans Services at 302-739-2792, or make an appointment with the VBA Regional Office at 302-994-2511, extension 4845.

Second, VA will begin processing most PACT Act-related benefits claims on January 1st, the earliest date possible. And if you apply for PACT Act-related benefits before August 10th of next year, then your

benefits will be backdated to August 10, 2022, the day President Biden signed the bill into law. So, get your claims in as soon as you can.

Third, I hear some Veterans are worried that applying for PACT Act benefits will impact their current benefits. The truth is, with the PACT Act, you're 32 times more likely to have your benefits increase, or stay the same, than to see a decrease.

Fourth, there are people out there who will try to convince you that you need to pay someone or use a lawyer to apply for VA benefits. Not true. Applying for your PACT Act benefits is free, and easy, by working directly with VA, or a Veteran Service Organization.

And fifth, you can learn more about the PACT Act — and apply, anytime — by visiting [VA.gov/PACT](https://va.gov/PACT) or calling 1-800-MY-VA-411.

So, join the nearly 190,000 Vets and survivors who've already applied for their PACT Act-related care and benefits.

Listen, whenever someone signs up to serve our country in the military, our nation makes them a promise. If you fight for us, we'll fight for you. If you take care of us, we'll take care of you. If you serve us, we'll serve you when you come home. Our nation as a whole makes that promise, but it's our mission here in Delaware and across the country to keep that promise to all Veterans, their families, caregivers and survivors.

The PACT Act will help us keep that promise. President Biden is leading the way to keep that promise. And we will not rest until every Veteran and survivor knows about this new law, understands what it means for them, and gets the care and benefits they've earned. That's what our country owes you. That is what we will deliver.

With that, it's my privilege to introduce someone who doesn't really need a lot of introduction in these parts. Senator Carper's the last serving Vietnam Veteran in the US Senate. And he's given more than 40 years of devoted service and strong leadership improving Veterans' health care and services here in Delaware, and across the country. Join me in welcoming a 23-year Veteran of the U.S. Navy and Naval Reserve, Captain and Senator Tom Carper.

BE VIGILANT OF PACT ACT SCAMS

On August 10, President Biden signed the Sergeant First Class Heath Robinson Honoring our Promise to Address Comprehensive Toxics Act (PACT Act) into law. This law helps millions of Veterans and their survivors by:

- Extending VA health care eligibility for Veterans with toxic exposures and Veterans of the Vietnam, Gulf War, and Post-9/11 (Post-September 11, 2001) eras
- Expanding benefits eligibility for Veterans exposed to toxic substances and their survivors



Tips to Avoid PACT Act Scams

Scammers are taking advantage of new opportunities to commit fraud. There's been an increase in PACT Act-related phishing (email), vishing (phone), and social media scams targeting Veterans to access their PACT Act benefits or submit claims on their behalf.

Veterans should be cautious of anyone who guarantees a lucrative financial benefit or service.

Do's

- ✓ You may submit your application securely [online](#) via VA.GOV or in person at any Regional Office. You may file your claim directly with VA and then, VA will assist in gathering evidence necessary to support it. There are no costs or hidden fees to apply.
- ✓ Be cautious of companies who advertise VA benefits can only be obtained with their help. These companies may not be recognized by VA and may be attempting to charge illegal fees.
- ✓ Be cautious of aggressive companies who may try to pressure you to sign their contract through frequent communications or by insisting "you must act now or lose your chance for benefits."
- ✓ Be cautious of companies who claim to be contacting you on behalf of VA or to have a special relationship with VA. Contact VA at 1-800-827-1000 if you are unsure about the authenticity of any message received.
- ✓ Validate: If you are interested in working with a Veteran Service Organization (VSO), agent, or attorney, use the Office of General Counsel [Accreditation tool](#) to confirm and validate their credentials.

Don'ts

- ✗ Do not sign a contract agreeing to pay an unauthorized company a percentage of your benefit payment in exchange for their assistance with your VA claim. If you need help filing a claim, there are representatives of VSOs, agents, and attorneys who have been [accredited by VA](#) to assist you.
- ✗ Do not sign a blank form for someone else to complete later. Always review the completed form before signing and keep a copy for yourself.
- ✗ Do not be fooled by companies who advertise they have special relationships with medical professionals and can guarantee your benefits award. If they are defrauding the Federal government, you could be held responsible for paying those benefits back.
- ✗ Do not provide your social security number, medical records, or other personally identifiable information to anyone offering claims assistance before confirming their credentials using the Office of General Counsel [Accreditation tool](#).
- ✗ Do not sign forms that are not [VA generated](#) or third-party authorization for someone to provide "behind-the-scenes" claims assistance.

AGENCY ACCOMPLISHMENTS FOR FY22

- KDVA received the Citation of Appreciation from Kentucky's House of Representatives.
- Veterans Program Trust Fund (VPTF) granted a total of \$556,027 to 25 grantees.
- Homeless Veterans Trust Fund granted a total of \$157,812.66 to 417 grantees.
- Veterans Cemeteries performed 1691 internments during FY22.
- The Benefits Division generated over \$428.16 million dollars in entitlements and pensions for Kentucky veterans, widows, and dependents for FY22.
