VA announces \$10M in new funding opportunities for state, territory, and Tribal governments to help understand and prevent Veteran suicide

The U.S. Department of Veterans Affairs announced \$10 million in <u>new funding</u> for eligible states, territories, and Tribal governments through cooperative agreements to better inform Veteran suicide prevention strategies.

These cooperative agreements will provide funding and technical assistance intended to establish, coordinate, and manage suicide mortality review committees, which identify and characterize suicide deaths. Suicide mortality review committees help establish a local understanding of suicide, identify populations or locations of special concern, and inform the development and implementation of data-informed suicide prevention strategies for Veterans.

This funding opportunity advances VA's <u>National Strategy for Preventing Veteran Suicide</u>, the Biden-Harris administration's <u>strategy to reduce military and Veteran suicide</u>, and President Biden's Unity Agenda for the nation.

"One Veteran suicide is one too many, and we will stop at nothing to end Veteran suicide," said **VA Secretary Denis McDonough**. "Launching this first-of-its-kind initiative will allow us to better understand suicide deaths and, as a result, deliver better interventions to prevent Veteran suicide."

This initiative also contributes to the objectives of the <u>Governor's Challenge</u> — a partnership between VA and the U.S. Department of Health and Human Services' Substance Abuse and Mental Health Services Administration — which is actively engaging 55 states and territories to develop state-wide suicide prevention best practices for service members, Veterans, and their families.

This funding is for one year, with awards expected to be made no later than Sept. 30, 2024. The application period for this opportunity opened June 21, 2024 and closes July 24, 2024 at 4:59 p.m., ET. More information can be found in the <u>notice of funding opportunity</u>.

VA extends presumptions of service connection for three new cancer types

The U.S. Department of Veterans Affairs is including three new cancer types in the list of presumed service-connected disabilities due to military environmental exposure under the <u>PACT Act</u>. This announcement marks the continued commitment under the <u>Biden-Harris administration's Unity Agenda</u> and the <u>Biden Cancer Moonshot</u> to support the nation's Veterans.

Through a sub-regulatory policy letter published to the <u>Federal Register</u>, the following three cancer types have been included in the list of presumptive diseases:

- · Male breast cancer.
- Urethral cancer.
- Cancer of the paraurethral glands.

This policy establishes presumptions of service connection for eligible Gulf War and post-9/11 Veterans who deployed to Afghanistan, Somalia, Djibouti, Egypt, Jordan, Lebanon, Syria, Yemen, Uzbekistan, and the entire <u>Southwest Asia theater of operations</u>, which includes Iraq. Presumptive service connection means VA automatically assumes service connection for the disease and provides benefits to eligible Veterans who have submitted claims with evidence of a diagnosis.

"We are working with urgency to deliver on the promise of the PACT Act to provide health care and benefits to as many toxic-exposed Veterans as possible — we're leaning in wherever we can," said **VA Secretary Denis McDonough**. "VA is working with one goal in mind: getting today and tomorrow's Veterans and their families the benefits they deserve as fast as possible."

Any Veteran who currently has or previously had one of the listed cancers at any time during military service or after separation may be entitled to disability compensation benefits dated back to Aug. 10, 2022, the date the <u>PACT Act was signed into law</u>. VA will review all claims from impacted Veterans and survivors who previously filed and were denied for these three conditions on or after Aug. 10, 2022, to determine if benefits can now be granted. Veterans enrolled in VA health care can obtain cancer screening and treatment at VA, which recently announced <u>expansion of cancer care services</u> closer to where Veterans are.

VA has granted its <u>1 millionth PACT Act-related disability compensation claim</u> and awarded over \$5.7 billion to Veterans and survivors since President Biden signed the bill into law.

Veterans and survivors can apply or learn more about the PACT Act by visiting <u>VA.gov/PACT</u> or by calling 1-800-MYVA411.

There is no charge to file a claim with VA. For further assistance with the disability claims process, Veterans are encouraged to work with a <u>VA-accredited representative</u> or contact their <u>state Veterans affairs office</u>.



10,000th Interment at KVCC



Kentucky Veteran Cemetery Central (KVCC) was constructed on land donated by Fort Knox and officially opened on June 1, 2007, in Radcliff, Kentucky. US Army Sgt. Janice Ann Barno was KVCC's first interment on June 5, 2007. Since that time KVCC has strived to provide dignified burials for veterans and their spouse in a sacred space that stands as a tribute to their service to the nation and the Commonwealth.

On June 27, 2024, we will inter our 10,000th individual into the Kentucky Veterans Cemetery Central since opening on June 1, 2007. US Air Force Senior Master Sgt. (Retired) Richard McNary joined the Air Force in 1959, fought in the Vietnam War and was awarded a Bronze Star. He stayed in the Air Force for almost 25 years before retiring in 1984. He passed away on June 10, 2024, and will be laid to rest with his wife, Michiko McNary. Their name, like all the others, will be engraved on a Veterans headstone for all to see, adding their story to ours.

We have several memorials that have been placed by various Veterans Service Organizations to include a Veterans Memorial, POW/MIA memorial, Gold Star Families memorial and the largest 9/11 Memorial in the Commonwealth of Kentucky. These memorials and all the people who volunteer their time here, are to honor all our veterans who have served to protect this great nation. We also have some of the best veteran organizations and individuals that support the veterans and their family members that have been laid to rest here over the years. We are proud to be a part of this commitment to our veterans and their families.

We have interred Veterans that served in WWII, Korea, Vietnam, Iraq and Afghanistan. We are very proud to be part of their story as they chose KVCC as their final resting place. We are also proud of every veteran that is here, whether they served in a war period or not, because they all were trained, capable and willing to defend our great nation if called upon. We will continue to grow but we will always strive to display respect, dignity and compassion to all veterans and their families.

Veteran Designation on Kentucky Driver's Licenses and ID Cards: Kentucky offers a Veteran designation on Kentucky driver. Licenses and ID Cards to homosely discharged Veterans. Veterans must apply at the nearest Kentucky Driver Licensing Regional Ciffice. Veterans are required to provide a copy of one of the following documents as proof of eligibility:

Kentucky Sportsman's License for Disabled Veterans: Kentucky resident disabled Veterans: who have a 50% or more service-connected disability religing from the Van er eighbe for a three year Disabled Sportsman's License. This license costs S and includes Combination Hunting and Fishing Licenses, all Deer Pennits, Spring Turkey Pernit, Residen Pall Turkey Pernit.

Kentucky Income Tax Exemption for Military Pay: All military pay received for service in the U.S. Armed Forces is exempt from Kentucky Income tax. <a href="https://doi.org/10.1016/j.cs/10

Kentucky Military Retired Pay Income Taxes: The military retired pay of Service members who retired before January 1, 1998, is completely exempl From Kentucky Income baxes. Service members who retired from the U.S. Armed Forces after December 31, 1997, may exclude up to 351;100 their military retired pay from Kentucky income baxes.

Kentucky State Taxes on Military Disability Retirement Pay: Military Disability Retirement Pay received as a pension, annuity similar allowance for personal injury or sickness resulting from active service in the U.S. Armed Forces should not be included in taxable income. https://www.icp.oo/public/sickness/s525


