# VA awards over \$800 million in grants to help homeless and at-risk Veterans and their families.

The U.S. Department of Veterans Affairs announced it will award \$806.4 million in grants to help homeless and at-risk Veterans through the <u>Supportive Services for Veteran</u> <u>Families</u> and <u>Homeless Providers Grant and Per Diem</u> programs.

- **Supportive Services for Veteran Families:** Through the SSVF program, VA is awarding 239 grants totaling approximately \$797.5 million to community organizations that help rapidly rehouse Veterans and their families, prevent the imminent loss of Veterans' homes, or identify more suitable housing situations.
- Grant and Per Diem Program: Through the GPD program, VA will award 14 grants totaling approximately \$8.9 million to community organizations that provide Veterans with transitional housing and case management including connecting eligible Veterans to VA benefits, community-based services, and permanent housing. These special need grants will fund approximately 105 transitional housing beds to support special populations of homeless Veterans including women, elderly, terminally ill, chronically mentally ill, or those who care for minor dependents.

Ending Veteran homelessness is a top priority of VA and the Biden-Harris Administration. The number of Veterans experiencing homelessness fell by 4.5% between 2020 to 2023 and has dropped 52% overall since 2010. These grants also build upon the significant progress to end Veteran homelessness, including progress towards VA's fiscal year 2024 goal to house 41,000 more homeless Veterans. In 2023, VA placed more than 46,500 homeless Veterans into permanent housing, exceeding the goal set for 2023 by nearly 23%.

"We're making real progress in reducing Veteran homelessness, but there is much more work to do," said **VA Secretary Denis McDonough**. "These grants allow VA and the entire Biden-Harris Administration, alongside community partners, to provide more housing and wraparound services to more homeless and at-risk Veterans than ever before." These efforts are built upon the evidence-based <u>"Housing First" approach</u>, which prioritizes housing Veterans, followed by providing them the wraparound support to stay housed, including health care, job training, legal and education assistance, and more.

These new grant awards come just a week after the U.S. Department of Housing and Urban Development (HUD) and VA <u>announced policy changes</u> that will help more Veterans receive housing assistance under the HUD-VA Supportive Housing (HUD-VASH) program. The changes include requiring public housing agencies that administer HUD-VASH to set initial income eligibility at 80% of area median income, and excluding Veterans' disability benefits when determining income eligibility — both of which are expected to increase the number of Veterans eligible for housing assistance. ## VA takes steps to expand access to benefits for Veterans who served at K2 and their survivors.

The Department of Veterans Affairs announced several steps to expand access to VA benefits for Veterans who served at Karshi-Khanabad (K2) base in Uzbekistan after Sept. 11, 2001, as well as their survivors. These steps include:


- Making chronic multi-symptom illness a presumptive condition for K2 Veterans: VA plans to take steps to consider Veterans who served in Uzbekistan as Persian Gulf Veterans, therefore making undiagnosed illness and medically unexplained chronic multi-symptom illness (also known as Gulf War Illness) presumptive conditions for Veterans who served at K2. This will lower the burden of proof required for Veterans who served at K2 to receive presumptive benefits for these conditions.
- Recognition of exposures at K2 as toxic exposure risk activities (TERAs): VA also plans to take steps to acknowledge that Veterans who served at K2 were exposed to several contaminants of concern including for example jet fuel, volatile organic compounds, particulate matter and dust, asbestos roofing tiles, and lead-based paint. VA continues to work with the Department of Defense to conduct research to identify any additional exposures.
- Ensuring that toxic exposures are fully taken into account when processing K2 Veterans' claims: VA will provide information and training about service at K2, including a list of the contaminants that Veterans were exposed to while serving there, to all claims processors and examiners. This will mean that every time a K2 Veteran submits a disability claim, VA claims processors and examiners will take those K2 exposures into account.
- **Pre-decisional review of K2 claims:** Before a decision is made on a K2 Veteran's claim, it will go through an additional review to ensure that all relevant information (including exposures) was taken into account, and that all benefits to which the Veteran is entitled have been granted. This will apply to any original claim for conditions that could be tied to exposures (for example, there would not be a review for a knee injury).

Importantly, in addition to these steps, all Veterans who served at K2 and meet <u>basic</u> <u>eligibility requirements</u> are already eligible to enroll in VA health care to get world-class, low-cost care for all their health conditions – without needing to apply for disability compensation first. These Veterans are also eligible for presumptive benefits for the more than 300 conditions <u>covered by the PACT Act</u>, meaning that they do not need to prove that their service caused their condition to receive benefits for it; instead, VA automatically assumes service-connection for the condition and provides benefits accordingly. Moving forward, VA will continue to evaluate additional ways to support K2 Veterans and their survivors. VA encourages all Veterans who served at K2 to apply for VA <u>care</u> and <u>benefits</u> by visiting VA.gov or calling 1-800-MYVA411.

"At VA, our goal is to provide *every* Veteran who served at K2 with the care and benefits that they deserve for their service to our nation — and that's what this effort is all about," said **VA's Under Secretary for Benefits Josh Jacobs.** "In addition to these important steps forward, we want all Veterans who served at K2 to know that they are currently eligible both to enroll in VA health care (without first applying for VA benefits) and for presumptive benefits for the more than 300 health conditions under the PACT Act. We encourage these Veterans — and their survivors — to apply for VA <u>care</u> and <u>benefits</u> by visiting VA.gov or calling 1-800-MYVA411. We will do everything in our power to get to yes and get you the care and benefits you deserve."

VA is conducting extensive outreach to K2 Veterans and their survivors to ensure they get the care and benefits they have earned. Partly due to these efforts, 13,002 K2 Veterans of the approximately 16,000 known K2 Veterans are currently enrolled in VA healthcare and 11,801 are service-connected for at least one condition.



# Pioneer Trace resident Ms. Wynema Sorrell honored for her Army Service

Ms. Wynema Prince Sorrell, a 95-year-old resident of Pioneer Trace Nursing Home, in Flemingsburg, Ky., was honored for service in the U.S. Army from 1950 to 1952, by the Kentucky Department of Veterans Affairs (KDVA), on Friday, August 2, 2024, beginning at 1:00pm.

"Ms. Sorrell graduated from high school in 1947. Times were hard for everyone back then, so after working on the family farm for a few years, she decided to join the Army in search of opportunities for a better career. She joined the U.S. Army in 1950 when she was 21 years old.



Wynema was sent to Fort Lee, Virginia, for her basic training. After basic training, she went to Motor Pool School and was then sent to the Pentagon where she worked as an assistant to the Colonel. When her work in the Pentagon was finished, she then went to Fort Meyer, Virginia, and worked as a food service specialist. She was in charge of all the food orders for the troops at that facility. She loved working with the troops.


Wynema loved her time in the military, however, her mother became very ill, so she decided it was best she go back home and take care of her mother. She was honorably discharged in June 1952. Her mother passed away shortly after she returned home.

Wynema has always been a strong supporter of the Veterans Administration and enjoys telling stories about her time in the military. She met her first husband, Richard E. Reed, Sr., also a US Army Veteran, shortly after returning home from the service. They married in 1953 and had seven children. Mr. Reed passed away in 1997. Wynema was married

for the second time in 2011 to Mr. Bill Sorrell, also a US Army Veteran, until his passing in 2013."

The ceremony honoring Ms. Sorrell for her service began with the Pledge of Allegiance; a welcome to the many guests and a reading of Ms. Sorrell's bio from KDVA Acting State Programs Director Everett Bracken (U.S. Army / Gulf War Veteran); remarks from KDVA Commissioner Whitney Allen and the presentation of a certificate of recognition for her service and a special coin on behalf of Gov. Andy Beshear; a pin from the KDVA; a special musical performance; the reading of the poem "The Noble and The Brave" written by Joanna Fuchs; a presentation of gifts, plaque, and pin from Hospice of Hope; a special salute from the two Women Veteran's present at the ceremony; a pin from the Women's Veterans Memorial, in Arlington, Virginia, where Ms. Sorrell's story which will be going into the repository, where it will be acknowledged so that her story will live on; a pin from Lady Veterans Connect in Winchester, Ky.; recognition of the Veterans who were present at the ceremony; and a closing Veterans prayer.

Thank you, Ms. Sorrell, for your service. Refreshments were served directly after.

### Who is eligible

Any owner of a noncommercial motor vehicle required to be registered for use on Kentucky Highways.

#### **Steps Requirement**

Application must be made at your local County Clerk's office. Upon receipt of this plate, your regular (special) issue license plate must be turned in or issued to another vehicle.

#### Decal Expires Customer's Birth Month

\$10.00 of the initial and \$5.00 of the renewal registration fee goes to the Kentucky Department of Veterans' Affairs. For more information, please visit <u>http://veterans.ky.gov</u>. This plate is available for personalization with an additional \$25.00 fee annually. Personalization is limited to a maximum of 5 characters.


