- 1. Vote ratified on three items that were approved by written vote that was mailed to each board member.
 - a. Kentucky Department of Veterans Affairs Homeless Veterans Trust Fund \$70,000
 - b. Kentucky Department of Veterans Affairs Burial Honors Program \$35,000
 - c. City of Ryland Heights Funds to assist with veterans' memorial \$750

New Business

- 1. Kentucky National Guard / U of L Behavioral Health Partnership Program \$75,000
 - Financial assistance to assist combat veterans through this initiative.
 - Board voted to table to a later meeting.
- 2. Ron Spriggs Exhibit of Tuskegee Airman \$8,500.
 - Funding to create two (2) busts of historic Tuskegee Airmen (Gen. Benjamin Davis, Jr. & BG Noel Parrish) both from Kentucky.
 - Board voted to approve \$8,500 to create two (2) busts of historic Tuskegee Airmen.
- 3. Kentucky Housing Corporation \$30,000.
 - Funds will be provided to the Kentucky Veterans Program Trust Fund for a loan program administered through the Veterans Homeless Program for surviving spouses of veterans only.
 - Board voted to approve accepting \$30,000 to assist Kentucky Housing Corporation with loan program for surviving spouses of veterans only.
- 4. Thomson-Hood Veterans' Center \$22,333.19.
 - > Funding to purchase Vital Sign Monitors.
 - Board voted to approve \$22,333.19 to purchase Vital Sign Monitors.
- 5. Western Kentucky Veterans' Center \$10,580.
 - Financial assistance to purchase Kawasaki Trans Mule 4X4 to transport veterans around nursing facility.
 - Board voted to approve obligating \$10,580 to purchase Kawasaki Trans Mule 4X4.
- 6. Kentucky Indigent Veterans' Burial Program \$30,000.
 - Funding to cover the Indigent Veterans' Burial Program shortfall for FY 13.
 - Board voted to approve the request for \$30,000 to cover the FY 13 shortfall for the Indigent Veterans' Burial Program.
- 7. Interlink Counseling Services \$30,000
 - Funds to assist in keeping the doors open from their depleted financial state.
 - Board voted to approve the request for \$30,000 assist with funding shortfall.
