- promulgate administrative regulations required for the effective administration of KRS 40.310
- through KRS 40.560. KRS 40.600 authorizes the Kentucky Department of Veterans Affairs to
- accept and expend moneys that may be appropriated by the General Assembly; and other monies
- 13 received from any other source, including donations and grants and other contributions from a
- 14 government unit and authorizes the department to administer the funds through the use of agency
- accounts. KRS 40.600 requires the Kentucky Department of Veterans Affairs to manage the funds
- 16 and authorize expenditures. This administrative regulation also establishes a coordinating
- 17 committee to make recommendations for fund expenditures and outlines the administrative
- procedures of the coordinating committee.
- 19 Section 1: Definitions.
- 20 (1) "Commissioner" means the Commissioner of the Kentucky Department of Veterans Affairs.
- 21 (2) "Coordinating Committee" means the Women Veterans Program Coordinating Committee.

- 1 (3) "Fund" means the Kentucky Women Veterans Program Fund.
- 2 (4) "Woman Veteran" means a woman who served in the United States Armed Forces or in forces
- 3 incorporated as part of the United States Armed Forces, and who was discharged under other than
- 4 dishonorable conditions.
- 5 Section 2. Expenditures and Fundraising.
- 6 (1) In accordance with this subsection and subsection (2) of this section, money appropriated from
- 7 the fund shall be expended in support of the Women Veterans Program's activities or events that
- 8 directly benefit women veterans, including the following activities or events:
- 9 (a) Educational sessions or training seminars focused on eligibility requirements for women
- veterans seeking federal and state veterans' benefits and services;
- 11 (b) Research projects focused on collecting and retaining demographic or service-connected
- disability data for Kentucky's women veterans;
- 13 (c) Dissemination of benefit information for women veterans through circulars, brochures,
- social media, and other media outlets;
- 15 (d) Annual meetings or conferences focused on engagement of Kentucky's women veterans
- and discussions of issues specific to women veterans;
- (e) Job fairs, job placement services, other similar programs, or a combination of these focused
- on employing women veterans;

- 1. A member appointed pursuant to subsection (1)(c) of this section shall serve for a period
- of two (2) years.
- 2. A member appointed pursuant to subsection (1)(d) and (1)(e) of this section shall serve
- for a period of three (3) years.
- 17 (4) The committee shall:
- 18 (a) Meet at the call of the commissioner of Kentucky Department of Veterans Affairs, at least
- once per quarter.
- 20 (b) Make recommendations for fiscally responsible uses of funds donated, gifted, or designated
- 21 to the Women Veterans Program, including:
- 1. Propose, investigate, and approve activities that support Kentucky's women veterans;
- 23 2. Establish guidelines for approved activities, including funding parameters.

- 1 (c) Prepare meeting minutes that summarize each meeting, including recommendations made
- 2 by the committee;
- 3 (d) Prepare an annual report that summarizes recommendations made by the committee and
- 4 financial activities undertaken on behalf of Kentucky's women veterans;
- 5 (e) Submit an annual report by July 20th of each year to be included in the Kentucky
- 6 Department of Veterans Affairs Annual Report.
- 7 (5) The commissioner shall assign duties as appropriate to the Kentucky Department of Veterans
- 8 Affairs' staff or members of the coordinating committee to assist with administration of the
- 9 committee.
- 10 Section 4. Coordinating Committee Procedures.
- 11 (1) Coordinating committee procedures shall be in accordance with the approved By-Laws of the
- 12 Women Veterans Coordinating Committee.

- (a) What this administrative regulation does: KRS 40.600 charges the Kentucky Department of Veterans Affairs with administering a program to service the approximately seven percent (7%) or 24,000 women veterans in the Commonwealth. Specifically, KRS 40.600 mandates that KDVA conduct outreach, advocacy, and education for Kentucky's women veterans.
- (b) The necessity of this administrative regulation: KRS 40.600 authorizes the Women Veterans Program to receive funding from not only the General Assembly, but also other sources such as grants and donations. Proposed regulation 17 KAR 06:020 will afford the Women Veterans Program the administrative bandwidth to carry out the mandates outlined in KRS 40.600.
- (c) How this administrative regulation conforms to the content of the authorizing statutes: Proposed regulation 17 KAR 06:020 conforms to the content of KRS 40.600 by focusing on conducting outreach, advocacy, and education for Kentucky's women veterans.
- (d) How this administrative regulation currently assists or will assist in the effective administration of the statutes: Proposed regulation 17 KAR 06:020 will assist in the effective administration of KRS 40.600 by outlining the Coordinating Committee's administrative functions; detailing the means in which funds can be expended; and affording a mechanism to determine how many of Kentucky's women veterans are reached by the initiatives of the Women Veterans Program.
- (2) If this is an amendment to an existing administrative regulation, provide a brief summary of: This is a new regulation.
 - (a) How the amendment will change this existing administrative regulation: Not Applicable.
 - (b) The necessity of the amendment to this administrative regulation: Not Applicable.

Women veterans account for approximately seven percent (7%) or 24,000 of Kentucky's veterans. Women veterans affected by the proposed administrative change include:
 - (a) those (including their legal representatives) who are seeking compensation and benefits from the U.S. Department of Veterans Affairs or from the Commonwealth of Kentucky.
 - (b) any individual or other organization (such as a veteran service organization (VSO)) inquiring about benefits and services to Kentucky's women veterans.

- (c) public and private organizations seeking to provide benefits or services to Kentucky's women veterans.

There will be no costs to the benefiting entities derived from compliance with this regulation.
 - (c) As a result of compliance, what benefits will accrue to the entities identified in question (3): Kentucky's women veterans will benefit from proposed regulation 17 KAR 06:020 by receiving more opportunities for education, advocacy, and outreach as it relates to claims, benefits, and services available to Kentucky's women veterans.

 - (a) Initially: There will be no costs to the administrative body either initially or on a continuing basis.

The "By-Laws of the Kentucky Women Veterans Coordinating Committee" is the 3-page committee handout that summarizes the requirements of KRS 40.600 and 17 KAR 6:020, while also establishing the Rules of Order for meetings efficiency and the responsibilities of KDVA staff members who support the administration of the coordinating committee.

By-Laws of the Kentucky Women Veterans Coordinating Committee

Pursuant to 40.600 and 17 KAR 6:020, the Kentucky Women Veterans Coordinating Committee shall operate under the following guidelines:

Modified Robert's Rules of Order:

In order to expedite the business of this Committee the following rules are established:

- 1. All meetings shall be convened at the call of the Chairperson.
- 2. A simple majority of 4 voting members shall constitute a quorum.
- 3. The first order of business shall be approval of the prior meeting's notes, agenda, or minutes.
- 4. Formal notes, agenda, and minutes shall be established by the Chairperson upon the promulgation of an administrative regulation. Until this regulation is promulgated, an abbreviated summary of each meeting shall be recorded.
- 5. Treasurer's report: The next order of business shall be a treasurer's report.
- 6. Any vote taken on any issue shall be preceded by a motion for action on that issue.
- 7. Any motion for action on an issue must receive a second on the motion to open discussion on the issue.
- 8. Once discussion on an issue is completed, motions will be recognized by the Chairperson to <u>favor</u> the motion, reject the motion, or <u>table the motion</u> for the next meeting.
- 9. Should any point of order require either the suspension of the rules or a supplement using the formal Robert's Rules of Order, the Chairperson may so suspend or supplement.

Officers of the Kentucky Women Veterans Coordinating Committee:

The following officers are established to operate and manage the meetings of this Committee:

- 1. Chairperson: The chairperson shall be any of three voting members designated by the Commissioner of the Kentucky Department of Veterans Affair.
- 2. Treasurer: The position of Treasurer will be held by KDVA Financial manager.

3. Secretary: The secretary shall be elected from the voting members and shall be responsible for taking notes to provide a summary of the meeting and record the summary in the Committee's records.

Goals of the Kentucky Women Veterans Coordinating Committee:

- 1. Each meeting shall foster free and open discussion on issues focusing on the women veterans of Kentucky.
- 2. Each meeting shall explore the following statutory goals of the Kentucky Women Veterans Program:
 - a. Equitable access of Kentucky women veterans to federal and state services and benefits.
 - b. Maximizing awareness in the Kentucky women veteran population about their services and benefits.
 - c. Assessing the needs of Kentucky women veterans regarding services and benefits.
 - d. Creating programs to facilitate a., b., and c. above.

Program and Event Planning by the Kentucky Women Veterans Coordination Committee:

Each meeting of this Committee shall consider ways to further the stated goals through:

- 1. Programs that advocate for Kentucky women veterans.
- 2. Programs that collaborate with federal, state, local, and private agencies on behalf of women veterans.
- 3. Programs that provide past and current statistics related to women veterans.
- 4. Programs, conferences, seminars, and training workshops sponsored by or in conjunction with federal, state, local, and private agencies which provide guidance to women veterans in accessing their services and benefits.
- 5. Programs of honor and recognition for Kentucky women veterans.

Expenditure of Funds:

1. The Committee will recommend to the Commissioner, via the Director, State Programs, and in consultation with the Treasurer, and in accordance with this subsection, expenditure of funds for programs or requests that directly promote the Mission of the Women Veteran's Program.

Fundraising:

- 1. In addition to appropriated funds, fundraising is permitted. The Committee may accept a gift, donation, or grant from an individual, a corporation, or government entity for deposit into the Kentucky Women Veterans Program Fund.
- 2. All monies received, regardless of source, shall be deposited into the Kentucky Women Veterans Program Fund.

Membership and Designation:

- 1. By KRS 40.600, the Committee's membership shall be composed of representatives of government, public, and private agencies that provide grants, benefits, or services to women veterans.
 - a. The Commissioner of the Kentucky Department of Veterans Affairs shall designate the private and public agencies represented on the Committee.
 - b. Where possible, at least seventy percent (70%) of the Committee must be women veterans.
 - c. The President of the KY Senate shall appoint a Senator to the committee.
 - d. The Speaker of the Kentucky House of Representatives shall appoint a Representative.

Terms of Members:

- 1. Except in cases of retirement from the board, resignation, or other inability or unwillingness to serve, the initial appointments to the Committee shall be as established in subparagraph a. of this paragraph.
- 2. Commissioner appointments serve for 3 years. Senate and House appointments serve for 2 years.
- 3. Members may be reappointed every 3 years; Maximum continuous tenure is 6 years.
