

VETERANS PROGRAM TRUST FUND

The Veterans Program Trust Fund (VPTF) was established as part of the Kentucky Vietnam Veterans' Bonus Act on December 23, 1988. The purpose of the VPTF is to direct funding to projects and programs that aid Kentucky's veterans. KRS 40.460(2)(b), KRS 40.310(7), and 201 KAR 37:010 outline assembly and population requirements for the Trust Fund Board of Directors.

The Board of Directors must consist of eleven members appointed by the Governor, representing the organizations detailed below:

VPTF's Financial Impact

Funding sources include dollars generated by taxpayers who receive an income tax refund and who contribute all or a portion of that refund to the Trust Fund through the tax check-off on their state income tax form. The Trust Fund also receives a \$5.00 fee that is included in the price of an initial or the renewal of a veterans' license plate. The Trust Fund also graciously accepts tax-deductible contributions from individuals, groups, or

corporations. This FY23 update outlines the amounts received from each of these sources.

The Trust Fund began the year with a balance of \$936,242.29. Expenditures during FY24 totaled \$910,329.96. The fiscal year ended with a fund balance, less obligations of \$676,650.12.

A Year in Review: FY24

During this reporting period, the VPTF obligated funds for 25 worthy projects that benefited the Commonwealth's veteran population. The Trust Fund Board of Directors also approved additional modifications to the application in conjunction with KDVA's website updates. Application enhancements, which have continued since FY20, have

significantly improved the quality of grant proposals and the effectiveness of Trust Fund expenditures.

FY24 Meeting Minutes at a Glance

The Board of Directors convened four times during FY24: 13 September 2023, 13 December 2023, 20 March 2024, and 12 June 2024. ORGANIZATION: **Veteran's Club**

REQUEST: **\$28,416** to support the expansion of their equine mentoring program in Kentucky.

BOARD'S AWARD: The Board voted to approve an obligation of \$28,416.

BOARD'S AWARD: The Board voted to approve an obligation of \$20,090.

ORGANIZATION: USA Cares

REQUEST: \$100,000 to provide emergency financial assistance for the Kentucky Army and Air National Guard units who experience natural disasters.

BOARD'S AWARD: The Board voted to approve an obligation of **\$10,000** pending detailed budget submission.

REQUEST: \$10,000 to grow their equine assisted therapy program.

BOARD'S AWARD: The Board voted to approve an obligation of \$10,000.

- Motion made by David Best (GAB) and seconded by Carla Raisler (KYNG).
- Motion for approval unanimously carried.

ORGANIZATION: Dogs Helping Heroes
REQUEST: \$47,547.00 to raise funds for the care and training of 9 service animals that will be provided to veterans.

BOARD'S AWARD: The Board voted to approve an obligation of \$50,000 (with stipulation).

- Motion made by and seconded by digital vote.
- Motion unanimously carried.

ORGANIZATION: Kentucky Veteran Business Alliance

REQUEST: \$50,000 to create an environment where veteran business is united in creating new business and increasing the job force.

BOARD'S AWARD: The Board voted to approve an obligation of \$17,340.00 as seed money for 5 veterans.

- Motion made by Carla Raisler (KYNG) and seconded by Tim Martinez (AL).
- Motion for approval unanimously carried.

ORGANIZATION: Morehead State University

REQUEST: \$6,000.00 to continue offering veteran affiliated students funds for books and supplies while in school.

BOARD'S AWARD: The Board voted to approve an obligation of \$6,000.

KENTUCKY VETERANS PROGRAM TRUST FUND BOARD MEETING 20 MARCH 2024

ORGANIZATION: Homeless Veterans Program (Interagency)

REQUEST: \$50,000 to prevent eviction and utility disconnection for veterans and their families.

BOARD'S AWARD: The Board voted to approve an obligation of \$50,000.

- Motion made by Carl Kaelin (VFW) and seconded by David Rummler (JECVO).
- Motion for approval unanimously carried.

ORGANIZATION: Clark County Veterans Council, Inc.

REQUEST: \$100,000 to build a public monument to honor the sacrifices of 101 Clark County residents who gave their lives in World War II and Korea.

BOARD'S AWARD: The Board voted to approve an obligation of \$100,000.

TRUST FUND APPLICANTS AND OUTCOMES

ORGANIZATION: Rowan County Veterans Foundation

REQUEST: \$500 to build a simulated "hooch" on the north wall of Vietnam room and display memorabilia.

BOARD'S AWARD: The Board voted to approve an obligation of \$500.

- Motion made by Dave Jarrett (DAV) and seconded by David Rummler (JECVO).
- Motion for approval unanimously carried.

ORGANIZATION: Honor Flight Bluegrass

REQUEST: \$105,000. \$80,000 to first fly up to 84 veterans and 84 guardians to Washing D.C. to visit the War Memorials built in their honor. Second, \$25,000 to fly WWII veterans in a WWII B-25 Bomber to various airports in KY.

BOARD'S AWARD: The Board voted to approve an obligation of \$105,000.

- Motion made by David Best (GAB).and seconded by Juan Renaud (KDVA).
- Motion for approval unanimously carried.

ORGANIZATION: Louisville Armed Forces Committee **REQUEST:** \$5,000 to recognize and honor KY Veterans at the Louisville Armed Forces Day Dinner

BOARD'S AWARD: The Board voted to approve an obligation of \$7,500.

- Motion made by David Best (GAB) to increase funding to \$7, 500 and seconded by David Rummler (JECVO).
- Motion for approval unanimously carried.

ORGANIZATION: Veterans Memorial Park of KY

REQUEST: \$30,192 to fund a monument that depicts the Spanish American and Philippine Wars.

BOARD'S AWARD: The Board voted to approve an obligation of \$30,192.

- Motion made by Tim Martinez (AL) and seconded by Dave Jarrett (DAV).
- Motion for approval unanimously carried.

ORGANIZATION: Honor Flight Kentucky Inc.

REQUEST: \$75,000 to fly KY Veterans to Washington DC to tour war memorials and lay a wreath at the Tomb of the Unknown Soldier.

BOARD'S AWARD: The Board voted to approve an obligation of \$75,000.

- Motion made by Dave Jarrett (DAV) and seconded by David Best (GAB).
- Motion for approval unanimously carried.

ORGANIZATION: Lady Veterans Connect

REQUEST: \$14,746 to host a weekend for women veterans at Cumberland Falls State Park.

BOARD'S AWARD: The Board voted to approve an obligation of \$14,746.

- Motion made by Carla Raisler (KYNG) and seconded by Amy McGrath (At-Large).
- Motion for approval unanimously carried.

ORGANIZATION: Operation Odyssey Outdoors

REQUEST: \$10,000 to sponsor a trip to Florida for 20 wounded heroes..

- **BOARD'S AWARD:** The Board voted to approve \$10,000 with the stipulation that the funding only benefit KY Veterans.
- Motion made by Carla Raisler (KYNG) and seconded by Carl Kaelin (VFW).
- Motion for approval unanimously carried.

ORGANIZATION: The Kentucky Veterans Hall of Fame

REQUEST: \$30,000 to recognize and honor KY Veterans in the KY Veterans Hall of Fame.

BOARD'S AWARD: The Board voted to approve an obligation of \$30,000.

REQUEST: \$50,000 to provide financial grants to KY Army and Air National Guard members experiencing periods of financial distress during national disasters.

BOARD'S AWARD: The Board voted to approve an obligation of \$50,000.

- Motion for approval unanimously carried.

ORGANIZATION: National Association for Black Veterans (NABVETS)

REQUEST: \$22,500 to honor veterans and their families through a Veterans Day parade in Paris, KY.

BOARD'S AWARD: The Board voted to approve an obligation of \$22,500.

- Motion made by Juan Renaud (KDVA) and seconded by Carl Kaelin (VFW).
- Motion for approval unanimously carried.

ORGANIZATION: Visual Presentations, Inc.

REQUEST: \$10,000 to honor our veteran community with a Veteran's Day parade.

BOARD'S AWARD: The Board voted to approve an obligation of \$10,000.

ORGANIZATION: Indigent Burial - Internal

REQUEST: \$25,000 to provide reimbursement for costs incurred burying an indigent veteran.

ORGANIZATION: Heather Renee' French Foundation for Veterans

REQUEST: \$15,000 to provide the 2024 Military Educational Display at the KY State Fair and pay tribute to Vietnam Veterans and their families.

BOARD'S AWARD: The Board voted to approve an obligation of \$15,000.

- Motion made by Carl Kaelin (VFW) and seconded by David Best (GAB).
- Motion unanimously carried.

ORGANIZATION: Veterans Walking Wounded Project, Inc

REQUEST: \$15,000 to assist veterans in the Fayette County Veteran's Drug and Treatment Court program.

BOARD'S AWARD: The Board voted to approve an obligation of \$20,000.

- Motion made by David Best (GAB) to increase amount to \$20,000 and seconded by Amy McGrath (At-Large).
- Motion for approval unanimously carried.
