REVIEW OF GRANT REQUESTS TOTALING \$176,583.33 for the following grants:

1. Project Healing Waters – Louisville Program (NO KY VENDOR #)

- Request for funding in the amount of **\$11,000** to provide the necessary equipment for veterans in the program to participate in fly fishing in the water.
- The Board voted to approve an obligation of **\$11,000**.

6. Veterans Walking Wounded Project, Inc. (KY0072251)

- Request for funding in the amount of **\$15,000** to assist veterans in the Fayette County Veteran's Drug and Treatment Court program.
- The Board voted to approve an obligation of **\$15,000**.
 - # Initial Motion made by David Best (GAB) to increase amount to \$20,000.
 - # Motion seconded by Amy McGrath (At-Large)
 - # Motion for approval unanimously carried.

7. National Association for Black Veterans (KY0059441)

- Request for funding in the amount of **\$22,500** to honor veterans and their families through a Veterans Day parade in Paris, KY.
- The Board voted to approve an obligation of \$22,500.

8. Indigent Burial - Internal

- Request for funding in the amount of **\$25,000** to provide reimbursement for costs incurred burying an indigent veteran.
- The Board voted to approve an obligation of **\$25,000.**

GRANT SUMMARY
