Therefore, totals from other geographic, PACT Act claims based, reporting will not align with this report.
2. Veteran Population projections were refreshed for the provided tables to produce projections in alignment with the 118th Congress. These updates account for minor changes in Veteran projections by state and in total when comparing these tables to the state table in the primary PACT Act Performance Dashboard.
3. Claims assigned to "CD Unknown" within a state represent claims for which the claimant address could not be accurately placed into an associated congressional district.
